FALL 2020 BUDGETS FOR CALCULATION OF CARES ACT GRANT

The following are baseline budget models for student expenses related emergency aid due to Covid19 disruption. Actual grants will be made using the institution's allocation policy.

Dependent students and independent students with no dependents or spouse: No allocation at this time, as in-person instruction is now permitted, and on-campus dormitory housing is open with appropriate health and safety provisions in place. Policy may be updated should circumstances change.

Budget for Independent student with dependents including spouse: Food and non-food/household Items including health care products - \$1,300, assistance with housing costs - \$1,100.

Institutional Allocation Policy Cares Act HEERF 18004a (1):As per department of Education guidance, only Title IV eligible students are eligible. Due to the Covid19 disruption, some Independent students with dependents including spouse may experience reductions and losses in other resources and support, which would have helped cover basic living expenses - food, housing, etc. The institution will provide HEERF 18004a(1) funds to enable students in this category to cover their food, housing, and material costs in an amount estimated to equal to other resources they might have had access to if not for the Covid19 disruption, up to a maximum of 2,400.
